	finish, not the textured one.

#### WILTSHIRE POLICE PARISH COUNCIL REPORT

## Savernake

#### Quarter 2 2025

#### Crimes and incidents

Wiltshire Police record crimes and incidents in accordance with the National Crime and incident recording standards. Not all incidents that one would consider a crime are necessarily classified as a crime for recording purposes.

NB- The below statistics do not account for incidents that police respond to but do not need any follow up (Road traffic incidents, minor incidents of Anti-social behaviour)

#### From 1st April 2025 – 30th June 2025

5 crime and 0 incidents have been recorded in the Savernake Parish area.

There have been 0 Reports of dwelling burglaries.

There have been 0 report in relation to theft of or theft from Motor vehicles.

Having reviewed the crime data for the area – There are no apparent trends that are presented or a series of crimes that are linked.

#### Speed enforcement

Both the local Neighbourhood Policing Team and the Speed Watch Enforcement Team have conducted several pro-active checks in the local area. Speed enforcement has taken place on at least 20 occasions in the Marlborough area between April-June 2025. Checks have also been completed at highlighted areas of concern including the approaches into town such as Port Hill and Poulton Hill.

During this period, 144 drivers have been offered speed awareness courses, 26 drivers have been issued with a fine and points on their license and 3 drivers have been reported to court for excess speed.



#### Recent updates•

In April 2025, Officers from the Neighbourhood Police Team have been involved in engagement activities regarding Operation Recall. This is a national initiative in the United Kingdom focusing on preventing livestock worrying, which occurs when dogs chase or attack livestock, causing harm and distress. This Operation involves a response from police forces, animal welfare charities and rural organisations. This multi-agency approach is used to raise awareness about responsible dog ownership and the dangers of livestock worrying.

- In May 2025, the local Neighbourhood Policing Team attended the VE Day event held at The Common, Marlborough. This was a fantastically supported event by the local community and the perfect opportunity to pay our respects to those who served and sacrificed in the Second World War. We would like to thank the Town Council for their efforts in arranging such a brilliant event.
- In June 2025, officers have been involved in the Summer Solstice operation at Avebury and have hosted several community engagement events in the local area both in the lead up to the event and the following days. Local officers have also been carrying out further community engagements at Nationwide, Marlborough Youth Centre and TH Whites.
- In the coming weeks, PS 0144 Deborah Laycock will be joining the Devizes Area Neighbourhood Policing Team to be the supervisor for the Marlborough and Pewsey area of the sector. We would like to congratulate PS Laycock on her appointment and look forward to working with her in the near future.
- On Thursday 12th June 2025, local officers on patrol were alerted to a suspicious incident on The Parade, Marlborough. A pro-active stop and search of a vehicle and three occupants subsequently took place. A significant amount of suspected Class A controlled drugs and three persons arrested on suspicion of possession with intent to supply controlled drugs and have since been bailed for further enquiries.

#### Community consultations

During this period there have been several formal community engagements held in the Marlborough Town area. Neighbourhood and Response Officers have also been conducting regular foot patrols in and around Marlborough Town Centre to deter shoplifting and other similar criminality. We have also made use of the 'Mobile Police Station' during this period to provide an opportunity for the more remote areas of the patch to engage with us. We are scheduled to have the 'Mobile Police Station' again the week commencing **Monday 7<sup>th</sup> July 2025**, further details about this will be advertised in due course. # THE COUNTY OF WILTSHIRE (PARISHES OF EAST WILTSHIRE) (PROHIBITION AND RESTRICTION OF WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING) CONSOLIDATION ORDER 2016 (AMENDMENT NO.11) ORDER 2025

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35 and 53 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

- The County of Wiltshire (Parishes of East Wiltshire) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2016 shall be amended by the insertion of the Map Schedules specified in the Schedule to this Order.
- 2. The effect of the Order will be to introduce **No Waiting at any time** on the following lengths of road:

Maurice Way, Savernake – north east side – from its junction with A4 London Road for a distance of 75 metres in a north westerly direction

Maurice Way, Savernake – south west side – from its junction with A4 London Road for a distance of 72 metres in a north westerly direction

 This Order shall come into operation on xxxxxxxx 2025 and may be cited as The County of Wiltshire (Parishes of East Wiltshire) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2016 (Amendment No.11) Order 2025.
